This seminar surveys the core traditions of urban sociology and their contributions to theory development and empirical research on contemporary urbanization. The first part of the course scans the theoretical and methodological approaches to the city and urbanization that are subsequently deployed to explore salient features of social structure, experience, and transformation of the metropolis over the entire course. The second part examines the relationship between urbanization and social inequality from a global perspective, focused on (1) connecting urban theory with concrete empirical studies and (2) bridging and relating studies from a wide range of global urbanizing contexts.

The course focuses particular attention on the impact of economic globalization and informational technologies on the material basis of urban inequality; processes and manifestations of racial, ethnic, and class segregation, interspersion, and containment from below (hyperghetto and slum) and above (gentrified enclaves and gated communities); quandaries of housing and houselessness; the sifting and sorting of new waves of immigration and their transformation of neighborhood institutions; and the connection between urbanization and proliferating ecological crises cascading across the planet.

This reading-intensive seminar is intended to introduce Ph.D. students and other aspiring urbanists the foundations of urban sociology and to provide a broad survey of the major themes, methods, and debates in this dynamic, interdisciplinary, and global research field. This is a “foundations” course oriented towards doctoral students and others interested in undertaking advanced scholarship in urban sociology and urban studies. The seminar is strongly encouraged for those interested in working with the instructor on a future exam, thesis, or dissertation. Works listed in the “supplementary” sections of each week are further suggestions for field exam reading lists.

## Requirements

- *Regular attendance and active engagement* in all sessions. Since we only meet once per week (10 classes total), this is a mandatory requirement. Students may miss one session without a grade reduction. If you are confronting any issues that are impeding your studies this term, please reach out to me so appropriate support can be found.
- *Weekly Reaction Memos (RMs)*. These are 2–3-page single-spaced memos to be posted by 4pm each Monday of the term. These should follow the specific format as outlined on the RM handout. When presenting, you have the option of composing a 1–2-page handouts in place of an RM. One RM can be skipped.
- *Class Presentations*: Students will take turns presenting on sets of texts in the seminar to assist in facilitating discussion. Each seminar one student will be responsible for presenting key arguments, merits, and these connections between the texts. Another will present on their limits and critiques. These presentations should be drawn off both your own reading and the weekly RM's submitted by others.
- *Final Papers*: Term papers should be geared towards students own research and training needs. This could include Qualifying Exam memo(s) (10 pgs), a draft of a research paper (20 pgs max), or a research proposal including MA Thesis, Dissertation, or grant (10-20 pgs). Alternatively, students could select to write a critical book review drawing centered on two to three books from which we read selections of or that are featured in the supplemental readings (10 pgs).

Final papers and a complete portfolio of RMs and presentation handouts will be submitted electronically by 5pm on Friday December 9.
